




Tidbits ...

Fire Extinguishers - What do those numbers mean?

The <u>Underwriters Laboratories</u> rate fire extinguishing capacity in accordance with UL/<u>ANSI</u> 711: Rating and Fire Testing of Fire Extinguishers. The ratings are described using numbers preceding the class letter, such as **1**-A:**10**-B:C. The number preceding the A multiplied by 1.25 gives the equivalent extinguishing capability in gallons of water for **A** class materials: Wood, paper, cloth, etc. The number preceding the B indicates the size of fire in square feet that an ordinary user should be able to extinguish (Class **B**: Flammable liquids, like diesel fuel, gasoline, etc.) There is no additional rating for class **C**, as it only indicates that the extinguishing agent will not conduct electricity and an extinguisher will never have a rating of just C. Whenever possible, de-energize equipment in electrical fires if safe to do so. On a boat this usually means turning off the ignition or battery switches. At home, turning off the switch, breaker or pulling the plug.

Help! How do I find North without a compass?



- Using an analog watch, put it on a flat surface aiming the hour hand to the sun. (5 pm on sample above). If on daylight savings time, deduct one hour, so aim the 4 o'clock mark to the sun.
- Divide the angle between the hour hand and the 12 o'clock mark (12 on the watch) so you can find the center point and draw a line passing through the center of the watch. In the above example, the line would fall between 2 and 3. That is the North-South line in the northern hemisphere.
- Now you know where North is... magnetic North that is, but you already knew that, didn't you?

For the southern hemisphere:

- Proceed as above, but aim the 12 o'clock mark to the sun.
- Divide the angle between 12 o'clock and the hour hand to find the North-South line. The top of the line will be pointing North.

Storm Surge

The greatest potential for loss of life related to a hurricane is from the storm surge!

Storm surge is simply water that is pushed toward the shore by the force of the winds swirling around the storm. This advancing surge combines with the normal tides to create the hurricane storm tide, which can increase the mean water level to heights impacting roads, homes and other critical infrastructure. In addition, wind driven waves are superimposed on the storm tide. This rise in water level can cause severe flooding in coastal areas, particularly when the storm tide coincides with the normal high tides. Because much of the United States' densely populated Atlantic and Gulf Coast coastlines lie less than 10 feet above mean sea level, the danger from storm tides is tremendous.

The storm surge combined with wave action can cause extensive damage, severely erode beaches and coastal highways. With major storm like Katrina, Camille, and Hugo, complete devastation of coastal communities occurred. Many buildings withstand hurricane force winds until their foundations, undermined by erosion, are weakened and fail.

Government Liaison Report

On matters of interest to pleasure boaters:

Canada Shipping Act 2001

Small Vessel Regulations now apply to pleasure craft of all sizes, passenger carrying vessels up to 15 gross tonnage (12 passengers or fewer), work boats up to 15 gross tonnage and human powered non-pleasure craft of all sizes.

Pleasure Craft Licenses are valid for ten (10) years from the date of issue, transfer or renewal. Existing licenses without an expiry date are grandfathered. Licenses will continue to be free of charge.

The prohibition on the carriage of propane by passenger-carrying vessels has been relaxed. Such vessels may now carry up to 30 kg. of propane subject to certain safety precautions.

Compliance Notices declaring that new vessels conform to existing construction standards will become the responsibility of the manufacturer/builder. Vessels built by any person for personal use or those of traditional wood construction will be exempt.

New Regulations for the Prevention of Pollution from Vessels will repeal and replace the existing Regulations for the Prevention of Pollution from Ships and for Dangerous Chemicals. At issue is the definition of "greywater". International requirements under Annex V of MARPOL include food waste in the definition of "garbage" and is therefore limited to areas outside the territorial sea while the Regulations for the Prevention of Pollution from Ships and for Dangerous Chemicals permits the discharge of ground-up food waste. Discussions on this matter have produced a consensus which now defines "greywater" as any drainage of wastewater, including water with liquefied food wastes, but not including drainage that is a source of sewage, water used to discharge cargo residues and water containing pollutants or any other wastes prescribed in either of the two sets of regulations. The intent is still to apply these regulations to vessels over 400 tons or that carry more than 15 people.

On this same matter, which falls under Federal jurisdiction, boaters should be aware that the BC Ministry of Environment has given notice that it intends to apply Provincial regulations to marine pollution infractions. Discussions are ongoing between Canada and BC to resolve the situation.

Small Vessel & Facility Security

Since Sept. 11th, 2001, Canada has made significant advances in building awareness and establishing a security culture for vessels and facilities regulated by the Marine Transportation Security Regulations. Attention is now being given to the small vessels (including all pleasure craft) that are not subject to the MTSR. Initiatives such as voluntary guidelines, outreach/education programs, waterway watch programs, exclusion zones, etc. will be considered. Waterways such as the Great Lakes and Puget Sound, which are shared with the United States, would undoubtedly be subject to jointly formulated security programs. 2010 Winter Olympics Security

Plans for security to ensure a safe Olympic games are ongoing although no details are being released at this time. Mariners should be aware that there will be increased water-based patrols of Vancouver Harbour and Howe Sound. The Port will continue operations although there will be waterside security zones established around Olympic venues on or near the water. Disruption is expected to be minimal. Boaters should monitor Channel 16 and Vessel Traffic (11 & 12) throughout the games and during the periods preceding and following them.

Marine Weather Forecasts

Concerns have been expressed regarding the format and accuracy of marine weather forecasts. A letter outlining specific concerns has been written by the co-chair of Canadian Coast Guard Lower Mainland Advisory Council to Environment Canada in hopes of initiating improvement. PMD members with concerns/opinions on this matter should relay them to me at their earliest opportunity.

A review of Sunshine Coast strip chart 3311 is planned for 2009. Completion in 2010

Sailing Directions will be made available in "Print on Demand" format. Publications will include monthly updates. CHS has endeavored to improve the quality of "Print on Demand" paper charts over the past two years; they believe they are now producing a superior product. User comments are invited.

Shoaling has been detected in the Nanoose Bay area. A Notice to Mariners is pending.

Serious silting is still taking place near the south shore of the Fraser River at the new Golden Ears Bridge. Dredging has been carried out but has not solved the problem. Boaters should be aware that the bottom dries at low water (locally known as Bilfinger Island).

Vessel Refueling

PMD members should note that the closed Imperial Oil marine fuel docks have not yet been reopened. Some marinas are now posting signs prohibiting refueling of boats on marina property.

VENUS

The VENUS project offers a new way of studying the ocean. VENUS makes use of Internet and telecommunications technology to create a permanent link to monitoring instruments on the seafloor. This gives scientists and the public an ongoing way of monitoring the ocean environment.

The name VENUS, short for Victoria Experimental Network Under the Sea, points to its location in southern British Columbia, Canada. As you see on our Locations page in the Research section, VENUS aims to study three sites near Victoria, BC: a location in Saanich Inlet north of Victoria, which went into operation in February of 2006; a location near the Fraser River Delta; and a location in the deeper waters of the Strait of Georgia. See the pages on each location to learn about their distinctive properties.

Each location is linked to the Internet with an underwater power and fibre optic <u>cable</u>. <u>Instruments</u> at each of the three locations are attached by their own cables to a node, which is the interface with the main cable.

The Saanich Inlet location hosts, among other instruments, a <u>still image camera system</u> and a hydrophone array. The <u>hydrophone array</u> has two hydrophones for creating audio recordings and a third hydrophone that allows researchers to analyze the intensity of each sound at a given frequency. Sample recordings and plots of sound by frequency are in our <u>Saanich Inlet sound gallery</u>. The still camera system, which can pan, tilt, and zoom, and create short movies, is used for short intervals each day so that the camera's lights do not affect the ecosystem around it. Samples of the images produced can be found in the <u>Saanich still image gallery</u>.
